Description of Easement

The full, free, uninterrupted, and unrestricted right, liberty, and privilege for the Crown, its servants, tenants, agents, workmen, licensees, and invitees (in common with the owner his, tenants, and any other person lawfully entitled so to do) from time to time and at all times by day and by night to go pass and repass, with or without horses and domestic animals of any kind and with or without carriages, vehicles, motor vehicles, machinery, and implements of any kind, over and along the land over which the right of way is granted or created.

1. The Crown shall at its own expenses maintain and keep in good repair the gravel driveway on the servient tenement.

2. The Crown shall at all times use its best endeavours to keep the easement land clean and tidy and free from all debris, rubbish, noxious weeds and other unsightly offensive or inflammable matter.
