**Vocational Training Council Act 1982**

**Contracting Industry Training Council Notice 1974, Amendment No. 1**

Pursuant to section 34 of the Vocational Training Council Act 1982, the Minister of Employment hereby gives the following notice.

**Notice**

1. This notice may be cited as the Contracting Industry Training Council Notice 1974, Amendment No. 1.
2. Clause 2 of the Contracting Industry Training Council Notice 1974 is hereby amended as follows:

- (a) By revoking paragraph (b) of subclause (1) and substituting the following:  
 "(b) One member appointed by the Transport Section, NZ Distribution Workers Federation";
- (b) by revoking paragraph (c) and substituting the following:  
 "(c) One member appointed by the New Zealand
