#### **Amending an Order in Council Making the Kapiro-Pungaere Irrigation Order 1984**

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 55 of the Public Works Act 1981, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby amends the Order in Council dated the 19th day of November 1984, and published in the *New Zealand Gazette* of 6 December 1984, No. 227, at page 5456, making the Kapiro-Pungaere Irrigation Order pursuant to section 208 of the Public Works Act 1981, firstly by deleting the third sentence in clause 5 and substituting the following sentence:

"Extra water will be available up to a total of 1500 cubic metres per hectare in any irrigation season, and the occupier shall be liable for an extra water charge based on the actual quantity used and at the same price per 1000 cubic metres as for the water availability charge."

secondly by deleting clause 11 and substituting the following clause:

"11. The minimum aggregate area of land occupied by any occupier that is to be included in the District shall be four (4) hectares."

and thirdly by deleting the Second Schedule and substituting the following schedule:

#### **Second Schedule**

#### **Boundaries of Kapiro-Pungaere Irrigation District**
