Notice of Order for Conditional Discharge Section 110 of the Insolvency Act 1967

In Bankruptcy in the High Court of New Zealand Hamilton Registry

Take notice that by order of this Court dated the 25th day of August 1989, it was ordered that:

The debtor (Milkeat Singh Randhawa) is granted an immediate conditional discharge pursuant to section 110 of the Insolvency Act 1967 but this discharge includes a business prohibition pursuant to section 111 in these terms:

"During the period from now until 31 December 1991 he may not, without the leave of the Court:

(a) Enter into or carry on any business or class of business either alone or in partnership with any persons during that period; and

(b) Be engaged in the management or control of any business carried on by or on behalf of or be in the employment of any of the following persons, namely his wife, any lineal ancestor or descendant of his, the wife or husband of such ancestor or descendant, any
