2. That the company shall henceforth have the rights, powers and privileges of a natural persons (including the powers referred to in subsections (1) (a) to (h) of section 15A of the Act).
3. That a copy (as annexed) to the memorandum of association as altered be delivered to the Registrar of Companies.
