

## Summary of Bills Introduced

### *Legal Services Bill*

This Bill makes provision for the regulation of publicly-funded legal services in New Zealand by making legal assistance and legal services more readily available to persons and groups of persons of insufficient means.

It consolidates and amends the Offenders Legal Aid Act 1954 and the Legal Aid Act 1969.

It extends civil legal aid to environmental proceedings.

It provides for civil legal aid to be granted to persons detained in certain institutions.

It provides for the establishment and funding of a nationwide network of community law centres.

It provides for the payment of interest on solicitor's trust accounts, and for that interest to be used for law-related purposes.
