# **Local Authorities Loans Act 1956**

## Auckland Regional Authority Special Order

That the Auckland Regional Authority in exercise of the powers vested in it by the Auckland Regional Authority Act 1963, section 39 and in pursuance of the Authority conferred upon it under the Local Authorities Loans Act 1956 and in exercise of all other powers enabling it on that behalf doth hereby resolve by special resolution intended to operate as a special order to borrow the sum of six million dollars (\$6,000,000) as a special loan to be known as Primary Roading Loan No. 1 1989, \$6,000,000 for the purposes of improvement works on the Primary Road Network.
