

## TARIFF INDUSTRY ASSISTANCE (DECISION) NOTICE NO. 1989/17

Decisions of the Minister of Commerce in respect of Part I and Part II of the Tariff

- 1 Notice is hereby given that the following decisions have been made in respect of the goods published in the Schedules to this notice.
