Third Schedule**Service Delivery Centres**

A service delivery centre shall provide services not less than those required for:

- The payment of money due to the council; and
- The provision of information relating to rates and other accounts due to the council; and
- The provision of information relating to the district planning scheme, bylaws or information otherwise necessary for the preparation of town planning applications, and permit applications; and
- The provision of information relating to community development and recreation; and
- The making of rates rebate applications; and
- The making of applications for housing accommodation; and
- The registration of dogs; and
- Such other purposes as the council considers appropriate.
