Area Health Board's Act 1983

The Hospitals Medical Information Notice 1990

Pursuant to section 50 (4) (1) of the Area Health Board's Act 1983, the Minister of Health hereby gives the following notice:

Notice

1. Title and commencement—(1) This notice may be cited as the Hospitals Medical Information Notice 1990.

(2) This notice shall come into force on the day after the day of its publication in the *Gazette*.

2. Disclosure of medical information to Committee of Inquiry into the death at Carrington Hospital of a patient, Manihera Mansell Watene, and other related matters which was established by warrant dated the 15th day of September 1990—(1) Any person to whom section 50 of the

Area Health Board's Act 1983 applies may, in accordance with subsection 4 (1) of that section, disclose to any of the persons named in subclause (2) of this clause any information—

(a) Which concerns the condition or medical history of Manihera Mansell Watene and any other person who is to appear as a witness before the Committee of Inquiry and who is, or has been, a patient at Carrington Hospital.

(2) The persons to whom information may be disclosed in accordance with section 50 (4) (1) of the Area Health Board's Act 1983, pursuant to subclause (1) of this clause are:
