### Waitemata Harbour Maritime Planning Scheme

#### Approval of Scheme Change No. 1: (Devonport Passenger Wharf)

*Pursuant to Town and Country Planning Act 1977*

Scheme change number 1 (Devonport Passenger Wharf) which introduces a new Port F1A zone and applies it to the Devonport Passenger Wharf so as to provide a planning framework for the redevelopment of the wharf, was approved by the Auckland Regional Council Maritime Planning Committee by a resolution passed at its meeting held on the 29th day of June 1990 after all objections, appeals and arbitrations relating to the change had been disposed of and the change had been amended to give effect to all objections and appeals allowed and all amendments of the change required by the Tribunal had been incorporated.

The Council has also resolved that the change shall come into operation on the date that it is gazetted being 22 November 1990.
