Public Works Act 1981

Land Declared to be Road, Road Stopped and Amalgamated in the Hastings District

Pursuant to Part VIII of the Public Works Act 1981, and to delegation from the Minister of Lands, the District Manager/Chief Surveyor, Department of Survey and Land Information, Napier:

(a) Pursuant to section 114 (1), declares the land described in the First Schedule to be road which shall vest in Tl Hastings District Council.

(b) Pursuant to sections 116 (1) and 117 (3), declares the road described in the Second Schedule to be stopped and further declares that the stopped road first, second and third
