Radiocommunications Act 1989

Statement of Government Policy and Directions to Secretary of Commerce

To the Secretary of Commerce.

I, Maurice Donald Williamson, Minister of Communications, acting pursuant to section 112 of the Radiocommunications Act 1989 ("the Act"), and pursuant to the policies of Government communicated to you in the Statement of Government Policy and Directions to Secretary of Commerce dated 30 November 1990, and published in the *Gazette* of 6 December 1990 at page 4581, hereby direct you as follows:

Notwithstanding paragraph (d) of the directions contained in the Statement of Government Policy and Directions to Secretary of Commerce dated 30 November 1990, you may grant radio apparatus licences to Telecom Corporation of New Zealand Limited ("Telecom") in relation to the ranges of frequencies 825.015 MHz to 835.005 MHz and 870.015 MHz to 880.005 MHz. Subject to the registration of management rights under Part II of the Radiocommunications Act 1989, every radio apparatus licence so granted shall expire on 30 June 1991, or, where Telecom can practically cease operations on those frequencies by an earlier date, that earlier date.
