The Traffic (Wairoa District) Notice No. 1, 1991

Pursuant to the Transport Act 1962, a delegation from the Minister of Transport, and a subdelegation from the Secretary for Transport, I, Carne Maurice Clissold, Controller, Road and Traffic Standards, give the following notice:

Notice

This notice may be cited as the Traffic (Wairoa District) Notice No. $1,\,1991$.

The roads specified in the First Schedule are declared to be closely populated localities for the purposes of section 52 of the Transport Act 1962.

The roads specified in the Second Schedule are declared to be 70 kilometres an hour speed limit areas pursuant to regulation 21 (2) of the Traffic Regulations 1976.

The Traffic (Wairoa District) Notice No. 1, 1987, signed on the 2nd day of March 1987*, and The Traffic (Wairoa District) Notice No. 1, 1989, signed on the 11th day of December 1989†, issued pursuant to section 52 of the Transport Act 1962, and regulation 21 (2) of the Traffic Regulations 1976 are revoked.

First Schedule

Situated within Wairoa District at Wairoa:

All the roads within the Wairoa Ward with the exception of:

No. 2 State Highway (Pokeno-Wellington via Gisborne): from the western boundary of Wairoa Ward to a point 150 metres measured westerly, generally, along the said State highway from Kitchener Street.

Mitchell Road: from the No. 2 State Highway (Pokeno-Wellington via Gisborne) to a point 50 metres, measured north-westerly, generally, along the said road from the said State highway.

Powdrell Street.

Rutherford Street: from Powdrell Street to a point 500 metres measured south-westerly, generally, along Rutherford Street from Kitchener Street.

Situated within Wairoa District adjacent to Wairoa Ward:

Crarer Street.
