The New Zealand Business Roundtable Name Order 1991

PURSUANT to section 33 (1) of the Companies Act 1955, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that an association about to be formed as a limited company under the name "New Zealand Business Roundtable" is to be formed with objects among those specified in section 33 (1) of that Act and intends to apply its profits, if any, or other income in promoting its objects, and to prohibit the payment of any dividends to its members, hereby makes the following order.

Order

- 1. Title and commencement—(1) This order may be cited as the New Zealand Business Roundtable Name Order 1991.
- (2) This order shall come into force on the day after the date of its publication in the *Gazette*.
- 2. "Limited" dispensed with—It is hereby directed that the association about to be formed as a limited company with the name "New Zealand Business Roundtable" may be registered as a company with limited liability, without the addition of the word "Limited" to its name.
