## Summary of Bill Introduced

### Finance Bill (No. 6)

This bill comprises two parts:

Part I provides for the Minister for State Owned Enterprises to transfer shares in Radio New Zealand Limited and Television New Zealand Limited. Other provisions relate to bonus bonds, training, retraining and employment of Maori, and the validation of fees and rentals collected in respect of West Coast whitebait stands.

Part II includes provisions dissolving the Clerks of Works Registration Board and the Quantity Surveyors Registration Board. This Part also makes amendments to a number of Acts including the Higher Salaries Commission Act 1977, the Superannuation Schemes Act 1989, the International Finance Agreements Act 1961, the Fire Service Act 1975, the Private Savings Banks (Transfer of Undertakings) Act 1992, the Crown Forest Assets Act 1989, and the Accident Rehabilitation and Compensation Insurance Act 1992.

## Government Notices

### Agriculture and Fisheries

#### Animals Act 1967

##### Tuberculosis Control Scheme: Compensation For Cattle Reactors (Notice No. 5188)

Section 53AA of the Animals Act 1967 provides for the Director-General of Agriculture and Fisheries, in consultation with the Animal Health Board, to fix the amount of compensation payable when cattle suspected of being infected with tuberculosis are directed to be slaughtered.

The amount of compensation is limited to a maximum set by regulation. The Cattle Brucellosis and Tuberculosis Control Regulations 1971 Amendment No. 12 has set this maximum amount at \$4,000. (This was set on the basis of 85% of the possible value of a stud bull and is far in excess of the usual amounts paid.)

Accordingly, the Director-General, in consultation with the Animal Health Board, has fixed different compensation rates which apply for tuberculin reactors found in herds in different areas according to the following rules:

- A. For reactors from herds that are considered by the Director-General to be at risk from Tb infected wild or domestic animals in the vicinity, the compensation will be at a rate of 85% of the market value of each reactor animal, up to the maximum allowable.
- B. For reactors from any other herd the compensation shall be at a rate of:
  - (i) 85% of market value (up to the maximum allowable) where no pathological evidence of tuberculosis is found on post mortem and/or laboratory examination of any reactor animal, or
  - (ii) 40% of market value (up to the maximum allowable)

where pathological evidence of tuberculosis is found in any reactor animal.

In exceptional cases, where the Director-General is satisfied that, through no fault of the owner, the number of cattle found with pathological evidence of tuberculosis in a herd within any 12 month period exceeds 20 percent of the average number of animals in the herd concerned during that period, the Director-General may, on the recommendation of the Animal Health Board, approve payment of compensation — at 85% of market value — for those reactors in excess of 20% of the total number of animals in the herd.

##### Determination of Market Value

For the purposes of this notice the value of any head of cattle shall be whichever is the lesser of:

- (a) The market value of the animal at the date on which the direction for its slaughter was given under section 53AA of the Act, assuming that the animal did not have tuberculosis; or
- (b) The maximum market value of cattle of that type at the date referred to in paragraph (a) of this subclause as determined by:
  - (i) The New Zealand Dairy Board, in the case of dairy cattle;
  - (ii) The Market Milk Federation of New Zealand Incorporated, in the case of town supply cattle;
  - (iii) The New Zealand Meat Producers Board, in the case of beef cattle.

The market value shall be determined by an Inspector, but where:

- (a) The value so determined is less than the maximum market value of cattle of that type determined by the appropriate body (above); and
- (b) The owner of the animal disputes the Inspector's determination, the matter shall be submitted to arbitration

under the Arbitration Act 1908, and the market value of the animal shall be determined upon the arbitration.

This notice takes effect from 3 December 1992.

### **Reason for this Notice**

The Animal Health Board has recently carried out a major review of the Tuberculosis eradication scheme. It recommended, and the Director-General has agreed, that the compensation regime be changed to create incentives which encourage farmers to manage their herds, particularly their inward purchases, so as to minimise the risks of introducing tuberculosis to hitherto uninfected herds and districts.

Owners can ascertain whether their herds are in category A or category B by enquiry to their nearest MAF office.

## **New Zealand Grown Fruit and Vegetables Regulations 1975**

### **Standard Grade for the Export of Fresh Blueberries Notice (Notice No. 5187, Ag. 12/2/14)**

Pursuant to the New Zealand Grown Fruit and Vegetables Regulations 1975\*, the Director-General of Agriculture and Fisheries hereby gives notice that the standard grade for the export of fresh blueberries shall be set out in this notice.

### **Notice**

**1. Title**—(1) This notice may be cited as the Standard Grade for the Export of Fresh Blueberries Notice 1992.

(2) This notice shall come into force on the day after the date of its notification in the *New Zealand Gazette*.

**2. Interpretation**—Unless the context otherwise required, terms and expressions used in this notice shall have the same meaning as in the New Zealand Grown Fruit and Vegetables Regulations 1975\*. Certain of these definitions as applicable to fresh blueberries set out in the First Schedule to this notice, together with the definitions with terms specific to this notice.

**3. Application of Notice**—This notice determines the standard grade for fresh blueberries exported from New Zealand.

**4. Title and Grade**—The grade mark assigned to this standard grade shall be Class 1 (hereinafter referred to as “the grade”).

**5. Definition for Produce**—This grade applies to blueberries grown from varieties of *Vaccinium* spp to be supplied fresh to the consumer.

**6. Provisions Concerning Grade Standard Requirements**—The purpose of this standard is to define the quality requirements for fresh blueberries at the dispatching stage, after preparation and packaging.

a. The blueberries must be:

- free from pests and diseases and meet any quarantine and other legal requirements of the importing country;
- intact, whole fruit;
- sound;
- clean;
- reasonably well formed—typical of variety and not more than slightly misshapen;
- free from abnormal external moisture;
- free of foreign smell or taste.

b. The blueberries must have been carefully picked and be of a similar degree of maturity and colouring in the same line of produce. They must have matured sufficiently to complete the

ripening process and be able to withstand handling, storage and transport.

c. The blueberries must be of good quality and have characteristics typical of the particular variety and be free of defects which:

- (i) may significantly impair the general appearance or keeping quality of the fruit; or
- (ii) are likely to make the fruit unattractive to the purchaser.

d. The flesh must be sound, but each blueberry is permitted a slight defect of shape, development or colouring and skin defects of a superficial nature such as those outlined in the Second Schedule to this notice.

**7. Provisions Concerning Sizing**—Sizing is determined by diameter of the berry.

The minimum size allowed for class 1 is 12 mm diameter.

### **8. Provisions concerning presentation—**

a. Uniformity:

For the purposes of the grade the blueberries in each package must be uniform, of the same origin, quality, degree of ripeness and size.

The visible part of each punnet must be representative of the entire contents.

b. Packaging:

The materials must be new, clean and of a quality such as to avoid causing any external or internal damage to the produce.

Packages must be free of all foreign matter.

**9. Provisions Concerning Marking**—Pursuant to regulation 16 of the New Zealand Grown Fruit and Vegetables Regulations 1975\* a tray is declared to be a package. Refer to “General Information” for requirements.

### **First Schedule**

#### *Definition of Terms:*

“Colour” means fruit should be a uniform blue in accordance with the varietal characteristics.

“Bloom” means the white waxy powder on the surface of the fruit.

“Maturity” means fruit is not to be soft, overripe or wrinkled.

“Clean” means free from dirt, dust, frass or the other foreign material.

“To pack” means to arrange fruit in a package so that they are not loose or compressed to an extent likely to cause damage to fruit during handling or transport.

“Sound” means free from decay, rots, overmaturity, breakdown, freezing injury, damage and similar defects which may cause rapid loss of condition or rapid decay.

“Wet” means that the individual berry is wet from juice from crushed, leaking, or decayed berries.

“Disease” means Anthracnose and *Botrytis*.

“Cap stems” means the stem attaching the berry to the plant.

“Clusters” means where two or more berries can be joined by their cap stems.

“Packaging” means packs must be of the prescribed weight, be clean, new and well made, must have the growers identification number clearly shown and the grade.

### **Second Schedule**

#### *Allowance for Defects*

Damaged Fruit:

“Damaged” includes cuts, punctures, torn scars, splits, cracks, hail damage chewed calyx, frost damage, surface russetting, deformed fruit, bruised fruit and any other readily noticeable damage.

Any damage in this category has to be relatively noticeable. Fruit should be free from any defects.

— Surface russetting, defined as any brown blemish or brown mark on the berry. Up to an aggregate area of 2 square millimetres is acceptable.

— Torn scars, a small tear is acceptable, large tears exposing the flesh are unacceptable.

— Bruised fruit/wet fruit that is soft, and weeping is unacceptable.

— Fruit wet from juice is unacceptable.

Colour:

Fruit must be a uniform blue in accordance with the varietal characteristics.

A maximum of 20 percent of red/purple of the berry is allowable.

The variety Delite is exempt from the above. This variety is acceptable with a purple/blue hue colour over all the berry. It must not be bright red obviously immature.

Cap Stems:

All cap stems to be removed.

Clusters:

These are not to be present.

Maturity:

Overmature must not be present.

Undermature must not be present.

### Foundation for Research, Science and Technology Act 1990

---

#### Statement of Science Priorities for the 1993/94 to 1997/98

To the Chairman of The Foundation for Research, Science and Technology, P.O. Box 12-240, Wellington.

Dear Professor Axford.

I am required under the Foundation for Research, Science and Technology Act 1990 to "... advise the foundation of the priorities that the foundation shall adhere to in carrying out its functions..." in the allocation of funds for the production of public good science outputs.

I am conveying this advice to you by means of this letter and Annexes A to H.

I note this statement is the first to present long-term priorities, and is to provide a basis for the allocation of the Public Good Science Fund (PGSF) for the financial years 1993-94 through to 1997-98. While the statement covers this entire period, it may be supplemented or modified if circumstances warrant, and is intended to be comprehensively reviewed in approximately 3 years time.

#### Strategic Goals for New Zealand Science

The Government believes that decisions on the funding of public good science need to be made in the context of clearly defined strategic goals. These goals need to express the Government's position on the overall strategic direction for research, science and technology, future funding levels, partnership with the private sector, the balance of research and development effort, the necessity for a concentration of resources and the need to add value. The foundation is thus to apply the strategic goals set out in Annex A in making funding allocations from the Public Good Science Fund.

#### Allocation of Funds

That part of the PGSF allocated by the foundation (i.e. excluding non-specific output funding) has been divided into 15 groupings containing combinations of 39 of the 40 output classes of the PGSF (output class 37: Health excluded).

Annex B lists the 15 groupings and shows the funding targets for each grouping and for outputs within each grouping where these are specified, for the 1997-98 financial year. In particular for the Infrastructure (output classes 19, 20, 21, 22, 23, 24) and Protection and Assessment of the Earth (output classes 29, 30, 31, 32 33) groupings, the funding levels as identified in Annex B for each output class, should be used as targets.

The foundation is to manage the allocation of funding so that these targets can be achieved.

#### Discretion in the Transition over the Five Year Period

The foundation will be allowed some discretion in the allocation of funding to output classes and groupings of output classes within the 5 year period, i.e. on an annual basis. However, the foundation is to develop an overall funding transition strategy and to advise me of the strategy by September 1993. Further details are contained in Annex D.

#### Development of Science Area Research Strategies

The foundation is to develop science area research strategies as a primary means of managing the allocation of funding over the

5 year period so as to achieve the target funding levels in the most effective and productive way. Strategies are to be developed through a process of widespread consultation with science providers, users of research in each science area and the associated sector.

A key consideration in developing science area research strategies should be the impact of funding from other sources, especially the private sector.

Science area research strategies should be formally advised to me, as they become available and no later than September 1993, to ensure that the implications of funding changes in particular are well understood and can be effectively managed.

Specific requirements for science area research strategies are set out in Annex E.

### ***Priority Research Themes***

Priority research themes, as set out in Annex F, are to be considered by the foundation in making funding allocations. Programmes relevant to priority research themes should be given priority consideration for funding, but this is not to be at the expense of maintaining a reasonable balance of relevant research across the PGSF. Relevance to a priority research theme should not override quality criteria.

Themes have been developed at three levels:

- generic themes across a large number of output classes;
- cross-output themes; and
- specific output themes.

As and when science area research strategies are developed, the Government may agree to modify themes or to concur with their incorporation into the science area research strategies.

### ***National Science Strategies (NSS)***

I wish to draw to the foundation's attention two cross-output topic themes of particular importance to Government. These relate first to climate change and secondly to the control of possums and the threat of bovine tuberculosis.

These cross-output themes are the subject of National Science Strategies (NSS) which have been developed and will continue to be developed by Committees which I have appointed for this purpose. The foundation is to take account of the strategies produced by the National Science Strategy Committees, when selecting programmes for funding.

The foundation is also to ensure that research in the NSS on possums and bovine tuberculosis should have separately identifiable and costed components either within research programmes or as separate programmes, and that research in any other NSS topic areas should be clearly and separately costed.

The foundation is to report its expenditure on NSS-related programmes after each funding round.

### ***Long-Term Programme Funding***

I wish to emphasise the Government's recognition of the long term nature of science and the necessity to fund appropriate programmes on a longer term basis. The guidelines which the foundation is to follow in this respect are set out in Annex G, part 1.

### ***Databases, Curations and Collections***

The Government considers that funding allocations should recognise the need to maintain and efficiently utilise science assets of national importance. The guidelines which the foundation is to follow in this respect are set out in Annex G, part 2.

### ***International Collaboration***

Science is becoming increasingly international in character, reflecting the increasing globalisation of economic activity, environmental and social issues, and the impact of communication and other new technologies. Internationalisation is recognised by the science community as a critically important factor. The guidelines which the foundation is to follow in this respect are set out in Annex G, part 3.

### ***Information and Technology Transfer***

I consider the transfer of information and technology derived from the research and development funded through the Public Good Science Fund to be an important consideration. It is only through the effective transfer, adoption and exploitation of the results of research and development that the outcomes desired by Government for New Zealand can be achieved.

The method the foundation is to apply to the treatment of information and technology transfer is set out in Annex G, part 4. However, the decisions on information and technology transfer should be applied on a case by case basis by the foundation without quantitative funding guidelines.

### ***Types of Research***

It is important that the foundation identifies and considers the balance of research effort directed to fundamental, strategic and applied research and experimental development.

Accordingly the foundation is to identify and monitor the breakdown between fundamental, strategic and applied research, and experimental development in each output class. Desirable shifts in this balance should be considered in applying the strategic goals specified in Annex A and in developing science area research strategies. The principles and definitions of these types of research and development activity are set out in Annex G, part 5.

### ***Criteria for the Selection of Research Proposals***

The selection of programmes must show a balance between the strategic importance of the research and its scientific quality. To achieve this, the foundation is to apply the selection criteria set out in Annex H. The foundation may apply additional criteria of its own which do not conflict with those in Annex H and which are in accordance with the requirements of the foundation for Research, Science and Technology Act.

**Reporting**

Notwithstanding that funding targets have been set in some cases by aggregations of outputs, the foundation is to report after each funding round on the funding it has allocated within each of the 40 output classes.

Please ensure that this statement of science priorities and any subsequent science area research strategies are conveyed to potential research programme proposers so that the Governments science priorities are given maximum effect in each funding round.

**Annex A: Strategic Goals for New Zealand Science***Overall Strategic Direction*

1. The key strategic direction for New Zealand's science and technology is to foster a sustainable, technologically advanced society which innovates and adds value, especially to our strong base of biological production.

*Funding*

2. The Government should review its investment in science and should especially encourage the private sector to increase its own investment.

*Partnership With the Private Sector*

3. The Government should encourage a harmonious and complementary relationship between its own research and development investment and that of the private sector.

*Concentration of Resources*

4. New Zealand must selectively support science in those areas which are of critical importance, and where research results can most readily be exploited.

**Strategies Underlying the Panel's Funding Recommendations***Balance in Research and Development Effort*

5. There should be a balance between research which contributes directly to economic performance and research which is of underpinning or indirect economic significance. Underpinning research includes the natural and social sciences, and infrastructure and environmental protection research.
6. A better balance of Government research funding along the value chain needs to be achieved with Government clearly targeting pre-competitive fundamental, strategic and generic/underpinning research. Industry should be encouraged to undertake more near-market research at the applied and development end of the spectrum, and to also provide more resources for applied and development research in primary production.

*Working in Harmony with the Private Sector*

7. Significant private sector research funding and successful market performance should not be penalised. Instead, there should be a more balanced and productive relationship between public and private funding ensuring successful utilisation of PGSF results.
8. However, an increase in PGSF funding to complement a high level of private funding should be conditional on a continuation or enhancement of funding from the private sector.
9. The Government should continue to provide a relatively strong focus on funding those areas of research which are inherently inappropriate for industry support.

*Concentration of Effort*

10. A key target for the PGSF is to focus on research in economic sectors which already have, or can readily develop, a competitive advantage.

The Government should fund cautiously in the case of "sunrise" industries and diversification where there is not yet a private capacity to fund the research and where private production, distribution, financing and marketing infrastructure required to exploit the research results is limited, and encourage private contributions if, and when, the industry expands.

*Adding Value*

12. There is a need for a shift in research emphasis from cost reductions and volume increases in primary production to adding value by other means such as improving the quality of primary products, market-oriented processing, and product development.

**Annex D: Discretion in the Transition Over the Five Year Period**

**Funding Targets**

1. The foundation should develop, by September 1993, an overall transition strategy covering that part of the PGSF allocated by the foundation, in consultation with the major science agencies, with this strategy setting out the way in which funding allocations will be managed in order to achieve the five year funding level targets. The transition strategy should be the outcome of aggregating the science area research strategies referred to below and should be advised to the Minister of Research, Science and Technology when it is complete.

**Transition Path**

2. The funding levels proposed at the aggregate level, or for individual outputs in two aggregations (outputs 19 to 24 and outputs 29 to 33), for 1997-98, as set out in Annex B, are firm goals towards which the foundation should work, bearing in mind that another review of five year priorities will be conducted in 1995. The overall transition strategy should clearly indicate the path expected to be followed in achieving these goals.

*Variation in Annual Funding Levels*

3. The foundation should fund within the range of the 1992–93 funding and the proposed 1997–98 funding by aggregate in each year, given that research programmes which fulfil criteria are available.

**Annex E: Development of Science Area Research Strategies***Science Area Research Strategies*

1. The foundation should develop long-term science area research strategies, at the level of individual outputs where output funding levels are stipulated in Annex C, but otherwise at the level of the output aggregations listed in Annex B. These long-term research strategies are to be formally advised to the Minister of Research, Science and Technology, before they are implemented and before significant shifts are made in funding away from existing levels for the outputs covered by each strategy. Guidelines for the development of the transition strategy and science area research strategies are as follows:

*Strategic Directions*

2. Science area research strategies should be in accordance with the strategic goals set out in Annex A and should take account of the indicative funding levels by output, as developed by the STEP and set out in Annex C.

*Core Programmes and Key Competencies*

3. Science area research strategies should aim to maintain the key competencies and core programmes required to achieve the strategic goals. To this end key competencies and the distribution of competencies between science providers should be identified in the research strategies.

*Impact on Science Providers*

4. Research strategies should contain sufficient information to enable the likely financial and human resource impact of the strategies on science providers, within the group of outputs or the output considered by each strategy, to be determined.

*Private Sector and Non-PGSF Funding*

5. Each strategy should include a consideration of the level of private sector and non-PGSF funding proposed or expected in that area of science. Strategies should take account of overall funding in the area, so as to minimise transitional difficulties and enhance complementarity between funding sources. Any structural difficulties in the private sector mobilising funding to adequately support the Government's strategic intentions as set out in the priority statement should be reported.

*Impact of National Science Strategies*

6. The foundation should carefully consider the impact of National Science Strategy research on other research in particular science areas, in developing and implementing science area research strategies.

**Annex F: Priority Research Themes**

Priority research themes will continue to be specified by the Government, recognising that themes may need to be modified as long-term research strategies are developed in each science area.

Priority themes are areas of research the Government considers of high relevance for funding from the Public Good Science Fund. The order of themes does not imply any preferential priority ranking.

This annex sets out in detail, in a modified format, the framework for priority themes. The structure consists of three tiers of themes:

- generic themes across all or a large number of output classes;
- cross-output topic themes; and
- specific output class topic themes.

**Generic Themes Across Outputs**

The Panel considers that generic themes which apply to all or a large number of output classes should be established. The themes recommended are:

- Sustainable development which seeks to incorporate environmental integrity and economic efficiency, to pursue equity, defined to include present and future generations and to recognise cultural as well as economic considerations.
- Relevant social research in every appropriate output class.
- Relevant environmental research in appropriate output classes.
- Implications for Maori cultural and economic development in appropriate output classes.

**Cross-Output Topic Themes***Control of Possums and the Threat of Bovine Tb*

The National Science Strategy Committee on Possums/Tb has reconfirmed the following themes which are the same as those in the 1992–93 Priority Statement:

- The epidemiology of Tb in farmed and feral animal species and control of Tb through biological means.
- The ecology of possums and other feral animals which may be vectors for Tb.
- Development of systems for controlling the possum population in New Zealand emphasising biological control systems and toxins alternative to 1080.

*Climate Change*

The National Science Strategy Committee on Climate Change has recently reported back to Cabinet. The report selected seven priority areas for additional emphasis within a wide ranging climate change programme. The Panel notes the recommendations of the Committee and lists the following priority areas:

- This country's responsibility for New Zealand/Southwest Pacific/Antarctic regional monitoring and modelling of changes in atmosphere composition, atmosphere and ocean climate, and sea levels including historical records.

- The combined effect of increased carbon dioxide, UV and other climate factors on plant growth and development, and research into processes of interaction.
- Regional climate modelling including extreme events, preferably in cooperation with overseas modelling groups and computer centres.
- Studies of physical and biological processes in the ocean and exchanges with the atmosphere of importance to climate change.
- The understanding of the variations in the sources and sinks of methane and nitrous oxide in particular New Zealand land utilisation situations.
- Improving knowledge of the carbon budgets in New Zealand ecosystems, including soils. Also, of the net carbon emission balance in New Zealand.
- Developing an impact assessment methodology for policy development and appraisal.

#### *Animal Welfare*

- Physiological, genetic and behavioural bases for, and causes of, animal stress and welfare emphasising domestic livestock, companion animals and pest management.

#### *Biodiversity*

- Description and analysis of biodiversity of indigenous and modified ecosystems and the management requirements for effective maintenance of these genetic resources.

#### *Hazard Mitigation*

- Description, analysis and management of hazards and hazardous materials for the purpose of improving the quality of life and minimising economic and social risks.

#### *Primary Production (Output Classes 1 to 10)*

- Sustainable development of primary production systems emphasising integrated management, and control of weeds, pests and disease.
- Sustainable development and management of soil and land resources, including development of plants for soil conservation and land rehabilitation.
- Understanding and manipulation of biological components, and growth and development, emphasising quality rather than quantity attributes.
- Product diversification through the evaluation, production, market assessment and industry infrastructure requirements where exploitation and commercialisation are more certain.
- Education, development and well-being of individuals, families and other social and ethnic groups in relation to development of primary production.
- Dynamics and culture of labour and work and the relationship to improving enterprise, investment and performance in primary production.

#### *Primary Processing (Output Classes 11 to 15)*

- Advanced and intelligent processing technologies that enhance productivity, product quality and diversity.
- By-product and waste minimisation and utilisation.
- The development of technologies that improve the efficiency of measuring, storage and transport, including energy efficiency.

#### *Secondary Manufacturing (Output Classes 16 to 19)*

- Equipment, plant and material reliability and maintenance.
- Intelligent and flexible process, product and construction control technologies and systems suited to the scale of New Zealand industry and to the exploitation of niche markets.

#### *Infrastructure (Output Classes 20 to 24)*

- Infrastructural resource identification and analysis and its integration and coordination into infrastructure planning, including information bases, as part of broader social, environmental and economic planning.

#### *Social Sciences (Output Classes 25 to 28)*

- Description and analysis of models for ensuring equity, development and integration of individuals, families and other social, cultural and ethnic groups.
- New Zealand trade and investment patterns, their relationship to labour force dynamics, the workplace, and development of an enterprise culture for a competitive economy.

#### *Protection, Exploration and Exploitation of the Earth (Output Classes 29 to 35)*

- Description and analysis of properties, processes, interactions and interdependence of atmospheric, land, freshwater, marine and geological resources, natural and modified eco-systems and their biota.
- Analysis and monitoring of the impacts of natural phenomena or human intervention on the natural environment over time.

#### *Nuclear Verification (Output Classes 38 to 40)*

- Take into account the Government's commitment to nuclear verification by seismological means and the need to contribute to a worldwide database of seismological events for this purpose.

### **Specific Output Topic Themes**

The following themes, specific to output classes, have been derived from last year's Priority Statement where they could not be encompassed in a cross-output topic theme, and from the deliberations of the Panel after consideration of the submissions. It is envisaged that they will be modified as output class strategies are developed.

*Output Class 3: Dairy Production*

- Development of methods for measuring, harvesting and transporting high quality milk and milk constituents.

*Output Class 4: Alternative Animal Species, Animal Products and Systems*

- Nutrition, physiology, genetics, health and diseases of alternative animal species for the purpose of improving or diversifying animal production systems or products.

*Output Class 5: Generic Animals and Animal Production Systems*

- Nutrition, physiology, genetics, health, welfare, diseases and pests of ruminant animals for the purposes of improving or diversifying animal production and products.

*Output Class 9: Trees and Plantation Management Systems*

- Assessment, development and management of tree species, especially alternatives to radiata pine, including indigenous plantation forestry, to meet future market needs and enhance the quality of the environment.
- Description and analysis of human and social factors and interactions, particularly Maori, in the forestry industry, and relationships between the industry, recruitment, skill base, safety and retention.

*Output Class 10: Fisheries*

- Enhancement of natural populations of harvested species through biological, chemical and physical assessment of water environments, aquaculture and biotechnology.
- Evaluation and development of improved systems and processes for aquaculture.

*Output Class 11: Meat, Meat Processing and Products*

- Seafood storage, handling, transport and processing emphasising fish species and products specific to New Zealand.
- Description and analysis of human and social factors and interactions, particularly Maori, in the meat and fish processing industry, and relationships between the industry and recruitment, skill base, safety and retention of people.

*Output Class 12: Dairy Processing, Storage Techniques and Products*

- Development of new techniques for quantifying the functional, nutritional and therapeutic properties and components of dairy products.

*Output Class 13: Fruit, Crops and other Food and Beverage Processing and Products*

- Evaluation and development of post-harvest disinfestation systems that are of quarantine importance for crops, horticultural and food exports and enhance the image of New Zealand products.
- Strategic generic food research which will underpin New Zealand's food industry and increase the competitiveness of products on international markets; including meat, fish dairy products, cereals, legumes, fruit and vegetables.

*Output Class 14: Fibre, Textile and Skin Processing and Products*

- Description and analysis of the physical and chemical properties of skins and natural fibres to better meet processing and consumer needs.
- Development of processes to improve skin processing and the quality of skin products.

*Output Class 15: Wood and Paper Processing*

- Development of new and improved solid wood products and processes, from radiata pine, that add value in New Zealand.

*Output Class 16: Materials, Industrial Processes and Products*

- Development of processes for adding value to products from local feedstocks, including waste and minerals.

*Output Class 19: Construction*

- Architecture, processes and products which minimise consumption of energy and enhance the environment, health and safety of occupants in both the construction and use of buildings.

*Output Class 20: Commercial and Trade Services*

- Development of new and improved information, technologies and processes that enhance New Zealand's international trade (including services and tourism).
- New and improved technologies and processes for improved managerial communication, problem solving and decision making in both quantitative and qualitative dimensions.
- Development and implementation of new and improved processes, systems and products for measurement related to quality conformance and competitiveness in products and services.

*Output Class 21: Energy*

- New and improved processes, systems and products for increased efficiency in the use and conservation of energy, alternative and renewable sources of energy including solar, wind and geothermal energy.
- Social research, including energy economics and development of sustainable energy strategies.

*Output Class 22: Transport Services*

- Enhancement of safety in transport of people and goods; including behavioural research.
- Energy efficient and environmentally sustainable transport systems.

*Output Class 23: Information and Communication Services*

- Development of new and improved processes, systems and products for maintaining privacy, security and confidentiality of information transmitted via electronic networks.

- Development, adaptation and exploitation of information and communication technologies to enhance New Zealand's economic efficiency and social services.

*Output Class 24: Urban and Rural Planning*

- Integrated planning and resource management systems to ensure sustainable social, economic and environmental development of human settlements, including processes appropriate for public participation.

*Output Class 25: History, Society and Culture*

- Human settlement in New Zealand; its history, origins, relationships, distinctive features and interaction with the natural environment, economic development and social change.
- Description and analysis of the origins and relationships of Maori society and culture.

*Output Class 26: Relationships and Wellbeing*

- Description and analysis of current family patterns; the formation, dissolution and reconstituting of families in New Zealand, and the impact on child growth and development, aspirations and motivation, and family violence.
- Systematic knowledge of relationships within work groups, and the changing patterns of ethnic and cultural relations, particularly between Maori and Europeans.

*Output Class 27: Political and Economic Relationships*

- Description and analysis of factors which limit or enhance participation in local, regional or national democratic processes, particularly by different ethnic, income and gender groups.
- Political and economic research directed at attaining sustainable management.

*Output Class 28: Education, Knowledge and Training*

- Development of New Zealand's human resources including skills formation and education delivery; process description, analysis, model development and use of technologies.
- Analysis of social, cultural and economic factors affecting educational participation, learning, occupation and career performance.

*Output Class 29: Environmental Protection*

- Development of processes, systems and generic technologies for sustainable management of New Zealand ecosystems subject to artificial modification and pollution; incorporating economic (monetary and non-monetary) and social values.

*Output Class 30: Geological Structures, Processes and Resources*

- Description and analysis of the structure and development of the New Zealand lithosphere and studies of crustal change, earth deformation, earthquakes and volcanism as manifestations of the plate boundary through New Zealand; emphasising the understanding of underlying processes and mechanisms.
- Description and analysis of the origins and evolutionary development of New Zealand's fossil flora and fauna emphasising their usefulness in determining age, environment and correlation of geological strata, and the timing of geological events.

*Output Class 31: Land Use, Flora and Fauna*

- Description and analysis of the biosystematics, adaptive ecology and genetics of indigenous and introduced flora and fauna and their impact on biota, land and water ecosystems.

*Output Class 32: Marine and Fresh Waters*

- Description and analysis of the hydrology and hydraulics of gravel-bed, braided river systems; including research predicting flood risk and mitigating flood damage.
- Integrated, multidisciplinary studies of key biological and physical processes within the water environments of the New Zealand region, including interactions with atmosphere and land energy flows between key biota, and relationships between primary productivity and new and recycled inorganic nutrients.

*Output Class 33: Climate and Atmosphere*

- Description and analysis of stratospheric ozone and of other gases aimed at understanding the chemistry determining ozone concentrations in the atmosphere; ultraviolet measurement and analysis including detailed spectral measurements.
- Description and analysis of sources, sinks, chemistry, physics and radiative effects of tropospheric gases, aerosols and clouds which contribute to radiative forcing of the atmosphere.
- Description and analysis of climate and weather dynamics and past climates, and development and validation of climate and weather modelling techniques, aimed at describing and understanding past and present New Zealand and South Pacific climate and weather, and predicting future variations in atmospheric circulation.

*Output Class 35: Antarctica*

- Description and analysis of the physical properties, dynamics and chemical constituents of the Antarctic atmosphere, sea ice and ocean.
- Description and analysis of the Antarctic weather, climate and climate change in the recent and geological past.
- Description and analysis of the biota and functioning of the ecosystems of the Antarctic.

## **Annex G: Structural Priorities**

### *1. Long-Term Programme Funding*

The foundation should continue to develop and apply a long-term (multi-year) funding approach which provides a consistent release of funding for reallocation each year that allows priority shifts to be achieved, but also enables funding stability to be given to long term and high priority programmes of research.

## 2. Databases, Curations and Collections

Arrangements should be set in place by the Foundation for Research, Science and Technology through a process of consultation with the science community, science providers, other funders and users if appropriate, to:

- identify databases, curations and collections of significant national importance that are funded through the PGSF which may include those type of asset which are subject to “covenants” in assets transferred to CRIs;
- ensure that the maintenance of each of these assets is funded and costed as an identifiable component within the foundation’s total portfolio, and as a priority within the relevant output classes; and
- ensure that a condition of funding is to provide access to these assets for scientific and other purposes by users, subject to the recovery of costs in providing such access.

The foundation is charged with taking the lead role, and should specifically integrate database, curation and collection issues into the research strategies in the appropriate science areas. The establishment and abandonment of nationally important databases should be carried out through a process of widespread consultation. This is to ensure that irreparable damage is not done to existing databases, curations and collections by expedient action.

## 3. International Collaboration

The foundation should identify international networking and collaboration in PGSF funded programmes, and should encourage such international links where these are appropriate to specific programmes.

## 4. Technology/Information Transfer

The foundation should require proposals put forward for funding to include consideration of technology and information transfer and to state separate technology and/or information transfer objectives where appropriate.

## 5. Fundamental, Strategic, Applied Research and Experimental Development

The foundation should require science providers to identify and monitor the breakdown between fundamental, strategic and applied research, and experimental development in each output class, and apply the strategic goals as stated in Annex A and consider the balance when applying the strategic goals in the development of strategies within science areas; with a particular emphasis on ensuring that increases in funding provide additional fundamental and strategic research and do not displace industry funding for applied research.

The definitions of the types of research to be identified as follows.

**Fundamental Research:** Experimental or theoretical activities undertaken primarily to acquire new knowledge of the underlying foundation of phenomena and observable facts, without any particular application or use in view. Sometimes referred to as pure or basic research.

**Strategic Research:** Research activities conducted to support long-term “national needs” and directed into specific broad areas in expectation of useful discoveries, or providing the broad knowledge base necessary for solution of recognised practical problems.

**Applied Research:** Research activities to acquire new knowledge which is directed primarily towards a specific and pre-determined objective or application, and including possible uses for the findings of fundamental research.

**Experimental Development:** Systematic work, drawing on existing knowledge gained from research and/or practical experience that is directed to producing new materials, products or devices, to installing new processes, systems and services, or to improving substantially those already produced or installed.

## Annex H: Criteria for the Selection of Research Proposals

In selecting research proposals for funding, the foundation should:

- (a) ensure that the following pre-conditions are satisfied:
  - (i) the proposal comprises public good science outputs as defined in the Foundation for Research, Science and Technology Act 1990;
  - (ii) proposers supply all the information requested by the foundation and required by the Ministry in order to effectively monitor the implementation of the priority statement.
- (b) ensure that the association of the research programmes with output classes accurately reflects the nature of the research proposed, even if this requires a proposal to be proportionately associated with several output classes.
- (c) apply the following criteria:
  - (i) the degree of scientific and technical merit;
  - (ii) the inclusion, where practicable and appropriate, of collaboration between research providers;
  - (iii) contribution to the fulfilment of the Government’s priorities;
  - (iv) the capability of the science provider to deliver the public good science outputs to the standards required; and
  - (v) relevance to indicative research strategies and topics developed as part of the National Science Strategy policy.

## Broadcasting Standards Authority

### Broadcasting Act 1989

**Broadcasting Standards Authority—Decision No. 57/92, 58/92, 59/92, 60/92, 61/92, 62/92, 63/92, 64/92, 65/92, 66/92, 67/92, 68/92, 69/92, 70/92, 71/92, 72/92, 73/92, 74/92, 75/92, 76/92, 77/92, 78/92, 79/92, 80/92, 81/92, 82/92, 83/92 and Interlocutory Decision No. ID1/92 and 2/92**

(i) In decision 57/92, the authority declined to uphold a complaint from the Growth Through Moderation Society of

Hamilton that the action taken by Television New Zealand Limited was insufficient having upheld a complaint about the broadcast of the *Steinlager Finest Tries* competition.

(ii) In decision 58/92, the authority declined to uphold a complaint from the Mental Health Foundation that the action taken by Television New Zealand Limited was insufficient having upheld a complaint about the broadcast of a promo for rugby league.

(iii) In decision 59/92, the authority upheld a complaint from the Auckland Women's Health Council that the broadcast by Television New Zealand Limited of an advertisement for Steinlager beer in February 1992 breached the responsibility placed on broadcasters that liquor advertisements shall not contain a direct association between the consumption of liquor and the operation of a motor vehicle.

(iv) In decisions 60/92, 61/92 and 62/92, the authority declined to uphold complaints from Mr Kerry Sharp of Palmerston North, Mr Clay Nelson of Wellington and the Christian Heritage Party of Christchurch that the broadcast by Television New Zealand Limited of *Sophie's Sex Special* on 6 May 1992 breached the responsibilities placed on broadcasters to maintain standards of good taste and decency, to respect the principles of law and to show balance, impartiality and fairness in programmes of a controversial nature.

(v) In decisions 63/92 and 64/92, the authority declined to uphold complaints from Mr Philip Smits of Auckland that the respective broadcasts by Radio New Zealand Limited and Radio Pacific Limited of advertisements for a nightclub in March 1992 breached the responsibilities placed on broadcasters to maintain standards of good taste and decency and not to encourage the denigration of, or discrimination against, a section of the community on account of race.

(vi) In decision 65/92, the authority declined to uphold a complaint from Mr Don Boscott of Paraparaumu that the broadcast by Radio New Zealand Limited of an item on a talkback show on 9 March 1992 breached the responsibilities placed on broadcasters to maintain standards of good taste and decency and not to encourage the denigration of, or discrimination against, a section of the community on account of sex.

(vii) In decision 66/92, the authority upheld a complaint from Mr Grant Rothville of Auckland that the broadcast by TV3 Network Services Limited, of a trailer for a film on 5 April 1992 breached the responsibilities placed on broadcasters to be mindful of the effect of a programme on children and that violence which will disturb is unacceptable during children's viewing times.

(viii) In decision 67/92, the authority declined to uphold a complaint from the Group Opposed to Advertising of Liquor of Hamilton that the broadcast by Television New Zealand Limited of the programme *Crowe on Crowe* on 23 March 1992 breached the responsibility placed on broadcasters to ensure that the incidental promotion of liquor is minimised.

(ix) In decision 68/92, the authority upheld a complaint from Mr Kristian Harang of Auckland that the broadcast by Television New Zealand Limited of an advertisement for Pioneer Electronics equipment on 6 June 1992 breached the responsibility placed on broadcasters that, in advertisements, women's sexual appeal may not be used simply to draw attention to an unrelated product.

(x) In decision 69/92, the authority upheld a complaint from Mrs Lauren Presland of Whangarei that the broadcast by Northland Radio Company Limited of an announcer's comment on 29 May 1992 breached the responsibility placed on broadcasters to maintain standards consistent with the privacy of the individual. The authority ordered the broadcaster to pay compensation to Mrs Presland in the amount of \$750.

(xi) In decisions 70/92 and 71/92, the authority upheld

complaints from the Group Opposed to Advertising of Liquor of Hamilton and Mrs Margaret Jackson of Cambridge that the broadcast by Television New Zealand Limited of liquor sponsorship advertisements on 5 April and 19 April 1992 breached the responsibility placed on broadcasters that the saturation of liquor advertising must be avoided.

(xii) In decision 72/92, the authority upheld a complaint from the Minister of Health that the broadcast by Television New Zealand Limited of an item on *Holmes* on 15 April 1992 breached the responsibility placed on broadcasters to present news accurately, objectively and impartially.

(xiii) In decision 73/92, the authority upheld a complaint from Mr M. C. Bradstock of Christchurch that the broadcast by Television New Zealand Limited of a Canterbury Draught beer advertisement in April 1992 breached the responsibility placed on broadcasters that liquor advertisements shall not contain a direct association between the consumption of liquor and the operation of a motor vehicle.

(xiv) In decisions 74/92, 75/92 and 76/92, the authority upheld complaints from the New Zealand Shooters Rights Association, the Otago-Southland Firearms Coalition and Dr L. A. Beltowski of Auckland that the broadcast by Television New Zealand Limited of an item on *Holmes* on 29 November 1991 breached the responsibility placed on a broadcaster to show balance, impartiality and fairness in dealing with current affairs. The authority ordered Television New Zealand Limited to broadcast a brief summary of the decision before 27 October 1992.

(xv) In decision 77/92, the authority declined to uphold a complaint from Mr Russell Garbutt of Dunedin that the broadcast by Radio New Zealand of an item on *Mana News* on 19 May 1992 and its repeat on *Good Morning New Zealand* on 20 May breached the responsibilities placed on broadcasters to respect the principles of law and to show balance, impartiality and fairness in dealing with controversial issues.

(xvi) In decision 78/92, the authority declined to uphold a complaint from Mr Mark Toomer of Christchurch that the broadcast by Television New Zealand Limited of the first episode of *Shortland Street* on 25 May 1992 breached the responsibilities placed on broadcasters to maintain standards of good taste and decency and to abide by the classification codes.

(xvii) In decision 79/92, the authority declined to uphold a complaint from Mr Robert Wardlaw of Auckland that the broadcast by TV3 Network Services Limited of a skit on the programming *Rowan Atkinson on Location* on 17 May 1992 breached the responsibility, among others, placed on broadcasters not to encourage the denigration of, or discrimination against, a section of the community on account of religious beliefs.

(xviii) In decision 80/92, the authority declined to uphold a complaint from Dr Jane Ritchie of Hamilton that the broadcast by Television New Zealand Limited of a trailer on 17 May 1992 breached the responsibility placed on broadcasters not to encourage the denigration of, or discrimination against, a section of the community on account of sex.

(xix) In decisions 81/92 and 82/92, the authority declined to uphold complaints from Ms Jackie Woolerton of Wellington that the broadcasts by Television New Zealand Limited and TV3 Network Services Limited, respectively, of a Chit Chat advertisement on 7 June 1992 breached the responsibility placed on broadcasters not to encourage the denigration of, or discrimination against, a section of the community on account of race.

(xx) In decision 83/92, the authority declined to uphold a complaint from Mr Philip Smits of Auckland that the broadcast by Television New Zealand Limited of an item on *Holmes* on 27 May 1992 breached the responsibility placed on

broadcasters to maintain standards of good taste and decency and to show balance when dealing with controversial matters.

(xxi) In interlocutory decision ID1/92, the authority decided in all the circumstances to decline to determine a complaint from Mr R. W. Kilgour of Alexandra about a broadcast by QFM Radio of Queenstown in April 1992.

(xxii) In interlocutory decision ID2/92, the authority decided in all the circumstances to decline to determine a complaint from Mr Donald Dorf of Auckland about a broadcast by Television New Zealand Limited of an item on *Tonight* on 18 June 1992.

## Wellington Central By-Election

### Qualification of Political Parties for Allocation of Broadcasting Time for Election Programmes

The Broadcasting Standards Authority ("the authority") is writing to broadcasters in Wellington, and national broadcasters whose signals are transmitted in Wellington, inviting them to make free time available to political parties for the broadcasting of election programmes before the Wellington Central by-election. While it has not received responses from all the broadcasters concerned, the authority gives notice, pursuant to section 70A of the Broadcasting Act 1989 (as amended by the Broadcasting Amendment Act 1990) ("the Act"), that any political party that considers that it will qualify for an allocation of time under section 73 of the Act (should it be made available by broadcasters) for the broadcasting of election programmes during the election period associated with the 1992 Wellington Central by-election ("the election") must, pursuant to section 70A, notify the authority in writing that it considers itself so qualified.

Any such notice must be received in writing by the authority no later than noon on Monday, 9 November 1992. It should be addressed to the Executive Officer, Second Floor, 54-56 Cambridge Terrace, P.O. Box 9213, Wellington.

Any political party that considers it will qualify for an allocation of time under section 73 of the Act in respect of the election period must state, pursuant to section 70B of the Act—

(a) the full name of the political party;

(b) in respect of each person belonging to the political party who has declared his or her intention of becoming a candidate at the election—

(i) the full name of that person; and

Under the provisions of section 70D of the Act any such person named in a notice to the authority shall, until noon on nomination day for the election, be deemed, for the purposes of subsection (1) (d) of section 75 of the Act to be a candidate at the election, whether that person is nominated or not.

The attention of political parties is drawn to section 75 (1) of the Act, which provides that—

"The authority shall not allocate any time to a political party under section 73 of the Act unless—

"(a) That political party conducts its affairs throughout New Zealand and has a national organisation; and

"(b) That political party has consistently expressed philosophies or policies on a range of issues over the

12 months immediately preceding the issue of the writ for the election; and . . .

"(d) In the case of a by-election,—

"(i) A person belonging to that political party is a candidate at that by-election; and

"(ii) Persons belonging to that party were candidates at the immediately preceding general election for at least 10 seats in the House of Representatives.

The authority requests that any party giving notice by the due date include submissions in support of its consideration that it qualifies for time, according to the criteria of section 75 (1); and for submissions on the allocation of time according to section 75 (2) and other relevant parts of the Act. Should free time be made available by broadcasters, the authority will consult with parties as required by section 76.

The Act further provides, in section 76, that the failure of any political party to give notice in accordance with section 70A of the Act or to avail itself of the opportunity to meet with and be heard by the authority under section 76, or to comply with any other request by the authority shall not prevent the authority from making decisions on the allocation of time, or affect the validity of those decisions.
