An Act to amend the Education Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1 Short Title

- (1) This Act may be cited as the Education Amendment Act 1996, and shall be read together with and deemed part of the Education Act 1989 (hereinafter referred to as the principal Act).
- (2) This Act shall come into force on the 1st day of January 1997.

Part 1

Control and management of state schools

2 Staff

This section substituted section 65 of the principal Act.

Part 2 Teacher registration

3 Interpretation

- (1) This subsection inserted section 120(ba) of the principal Act.
- (2) This subsection inserted the definitions **Registered private school**, **Satisfactory recent teaching experience**, **School authority**, and **Teaching position** in section 120 of the principal Act.
- (3) This subsection substituted section 122(d) of the principal Act.
- (4) This subsection substituted section 123(3) of the principal Act.

4 Restrictions on appointment and employment of teaching staff

This section inserted the heading "Restrictions on Appointment and Employment of Teaching Staff" and sections 120A and 120B of the principal Act.

5 Determining whether or not employment satisfactorily completed

This section substituted section 125 of the principal Act.

6 Appeals from decisions of Registration Board

9 Transitional

- (1) Subject to subsection (3) of this section, this subsection applies to every person who, immediately before the commencement of this Act,—
 - (a) Either held, or had been appointed to but not yet taken up, a teaching position (within the meaning of section 120 or section 315(1) of the principal Act); and
 - (b) Did not hold a **practising certificate** (within the meaning of section 120 of the principal Act).
- (2) Until the close of the 31st day of December 1997, the principal Act shall apply to every person to whom subsection (1) of this section applies as if that person holds a limited authority to teach.
- (3) Sections 130D and 130E of the principal Act shall apply to every person to whom this section applies as if the reference in section 130G to cancelling a person's authorisation is a reference to withdrawing the person's authority to teach; and where the Registration Board withdraws a person's authority to teach, subsection (2) of this section shall cease to apply to that person.

10 Consequential amendments
